This Juried show is open to Washington state artists of all ages and levels. The work will be exhibited from **September 25 – November 12** at the Lynnwood Library Gallery. **Application deadline is Friday, July 31, 2009.**

The exhibit will be juried by the Arts Commission, and the awards will be juried by a prominent local professional in the art community. The Arts Commission will present several awards at an artist reception on October 3<sup>rd</sup>, 2009.

The commission will also consider the artwork for purchase for the City's permanent collection. The Lynnwood Library Gallery is sponsored and maintained by the Lynnwood Arts Commission, with shows featuring local and regional artists working in a variety of mediums. No commission is charged for sales made. The gallery is visited by approximately 1,500 people monthly.

**Requirements and Conditions (Please read the following information carefully)**

- By applying to be in this exhibit, you agree to the terms and conditions stated in this form.
- Original art only. No copies or derivatives, reproductions or based on other copyrighted, published or photographed materials.
- One entry only.
- Two dimensional work may not exceed 24" x 24" framed. Entries must be suitably framed and wired for hanging. No brackets or adhesive tags.
- Sculpture and other 3D work may not exceed 10" x 10" x 16".
- Artists may not substitute another work for an accepted work, alter the work or withdraw the work after it has been accepted.
- We reserve the right to refuse, upon delivery, any piece of unacceptable quality, or any piece which does not match the photo or meet the size or framing criteria.
- We reserve the right to invite artists who do not apply, and to NOT select artists by this application process.
- We assume permission to reproduce accepted artwork for promotional uses, including the website.
- This space is visited frequently by children. Please consider your subject matter when applying.
- Further instruction for accepted works will follow with notification. Accepted artists will be notified by 9/1.
- Information subject to change without notice.

**Liability**

Please be advised that every reasonable precaution will be taken during the receiving, installation, exhibition and return of your artwork, but the Lynnwood Arts Commission, the City of Lynnwood, its officials, officers, employees or volunteers do not assume responsibility for loss or damage that might be incurred during this process. All work needs to be of substantial enough nature to withstand these procedures. We encourage each artist to carry their own insurance.

- Label CD with artist name and title of work. (Label prints on back with the same info as required for CD.)
