***1. Prioritization of Projects for the Survey***

The determination for the top five projects were as follows: 1) Manor Hardware; 2) Middleton Residence; 3) Masonic Temple; 4) Scriber Creek Bridge; and 5) Dollar Steamship Radio Station. The remainder of the list can be taken as listed. A discussion was had whether any building on a national register is already on the Lynnwood's Register of Historic Landmarks. Commissioner Sather made a motion to approve the listing as prioritized. Commissioner Tupau seconded the motion. Motion approved.

***2. Historic Recognition Plaques***

PhotoShop drawings from Fred Wong were reviewed. They seem too detailed for the product to be submitted to a brass manufacturer. Line drawings will be obtained for Scriber Bridge and the Wicker building (small drawing). Marie will work on the text for the two structures

***3. May Special Recognition Even***

A proclamation for the month of May will be written that will be presented to the Mayor and Council for the first Council meeting in May. Marie will provide a photograph of the Price/Weigel house for a Recognition certificate. A photo will also be obtained for Manor

Hardware. The recognitions will be on nice paper and framed. Marie will call the owner of the Price/Weigel House and Manor Hardware to have them present at the Council meeting.

Any functions in Heritage Park in May will need to have articles done before them that Marie will write. Staff will talk to Laurie regarding a location Peggy will be asked to coordinate the food.
